#### Sports Betting Guide

##### Football Rules

- 1.- For betting purposes, a football game (pro or college) becomes official after fifty-five (55) minutes of play.
- 2.- Games lasting under 55 minutes constitute "No Action" or "Push/Cancel" and the bet will be void. However, if quarters are completed that constitutes action on quarters.
- 3.- Betting on the game period spread, moneyline, or total (over/under) include any overtime scoring.
- 4.- 2nd Half betting includes any overtime scores. Fourth Quarter betting does NOT include overtime scores.
- 5.- If a game goes to overtime, finishing with a tie all bet types will be valid.

##### Basketball Rules

- 1.- For betting purposes, a basketball game becomes official after forty-three (43) minutes of play for pros, it is 48 MINUTES GAME, and thirty-five (35) minutes for all other leagues, it is 40 MINUTES GAME.
- 2.- Games lasting under official time constitute "No Action" or "Push/Cancel" and the bet will be void. However, if quarters are completed that constitutes action on quarters.
- 3.- 2nd Half betting includes any overtime scores. Fourth Quarter betting does NOT include overtime scores.

##### Hockey Rules

- 1.- For betting purposes, a hockey game (pro or college) becomes official after fifty-five (55) minutes of play.

##### Baseball Rules Regular Season

1. For game totals over (+) or under (-) will be valid when the team that's losing has exhausted there 9th inning. If the match is tied, a minimum of nine innings must have been played to be valid
2. All bets including: run line, super run line, run alt and money line will be valid when the losing team has hit their fifth (5th) inning. If the match is tied, minimum of five inning must have been played to be valid.
3. All play-to-play at half time will be valid when the losing team has hit their fifth (5th) inning. If the match is tied, a minimum of five full innings must have been played to be valid.
4. For halftime over (+) or under (-) will be valid when five full innings have been played.
5. For all solo (+) or solo (-) will be valid when the losing team has hit their (9th) inning. If the match is tied, a minimum of nine innings must have been played to be valid (extra innings are valid for over (+) or under (-).
6. First to score (FS) will be valid to the team that scores first, not the full inning and no matter how many innings are played for this mode (the game does not necessarily have to be official).

7. Will there be run scored in the first inning (YES-NO): all wagers will be considered official after first inning

8. Strikeout plays will be valid when the game is official, the team losing has hit the fifth (5th)inning.

9. Player proposition will be valid when the full inning has been exhausted. Player proposition will be valid when the losing team has hit their fifth (5th) inning. Both players may start. RULES FOR MLB DOUBLE HEADER:

When a double game is scheduled and one of them is cancelled, for betting purposes the game played will be the first game and all bets on second game will be void.

RULES FOR MLB PRE SEASON GAMES:

All games played 9 innings or more will be valid for RUN LINE and TOTAL (over / under) BETS. Including those games which finished tie.

RULES FOR International Baseball Events:

All games end by mercy rule, slaughter rule, knockout rule, or skunk rule will be valid for RUN LINE and TOTAL (over / under) BETS.

Soccer Rules

1.- All bets are based on the result at full-time. The terms full-time, 90 minutes play, and normal time are all used to denote the period of play that includes injury time but not extra time, penalty shoot-outs, etc.

2.- If a referee declares a game ABANDONED for any reason, wagers will be void.

3.- If a referee declares a game FINAL for any reason before 90 Minutes played, wagers will be valid.

Player Propositions

1.- Any players involved on (basketball or football) player propositions bets must take action at least on second on the game, otherwise the bet will be considered void.

Baseball Player Matchup

1.- On Total Bases Propositions, both players must start. A batter is only credited for bases if he hits a single (1 base), a double (2 bases), a triple (3 bases) or a home run (4 bases). A walk, hit by pitch, error, balk, fielder's choice, or passed ball do not count for Total Bases Propositions.

2.- This bet will be considered void if the game does not comply with paragraph 1.- of the "baseball rules" section.

3.- This bet will be considered void if a player belongs to a team which is scheduled on double game.

## Dois baleias-da-Baía resgatadas de Kharkiv, Ucrânia, e levadas para um aquário como aposta no sportingbet Valência, Espanha

Duas baleias-da-Baía foram resgatadas da cidade cercada de Kharkiv, na Ucrânia, e levadas para um aquário como aposta no sportingbet Valência, Espanha, como aposta no sportingbet uma operação complexa.

Um time multinacional envolvendo especialistas de cuidado de mamíferos marinhos do Oceanogràfic de Valência, o maior oceanário da Europa; Georgia Aquarium como aposta no sportingbet Atlanta; e SeaWorld participaram da jornada de alto risco.

A dupla de baleias-da-Baía - um macho de 15 anos chamado Plombir e uma fêmea de 14 anos chamada Miranda - chegou à noite na terça-feira como aposta no sportingbet "saúde delicada" após uma "jornada árdua", de acordo com o Georgia Aquarium.

Kharkiv, a segunda maior cidade da Ucrânia, que fica perto de como aposta no sportingbet fronteira com a Rússia, viu uma série de ataques russos nas últimas semanas.

No mês passado, um ataque russo como aposta no sportingbet um megastore na cidade matou 18 pessoas, incluindo uma menina de 12 anos, disse oficiais regionais.

"A cidade está enfrentando uma ameaça crescente de artilharia, que se intensificou nas últimas semanas, com bombas caindo a alguns centenas de metros do aquário", disse o Georgia Aquarium como aposta no sportingbet um comunicado à imprensa.

A jornada começou na segunda-feira quando a equipe primeiro removeu os golfinhos do NEMO Dolphinarium na Ucrânia e dirigiu-os por 12 horas de Kharkiv a Odessa.

Em seguida, viajaram para a fronteira com a Moldávia, onde os funcionários da UE arranjaram para acelerar o controle de fronteira.

Uma aeronave de seis assentos aguardava a equipe de resgate na capital moldávia Chisinau para voar para Valência, onde chegaram na terça-feira.

"A saúde e a segurança das baleias eram nossa prioridade absoluta, e essas foram condições desafiadoras, incluindo estradas ruins, temperaturas como aposta no sportingbet aumento e os riscos inerentes de estar como aposta no sportingbet uma zona de guerra ativa", disse Keith Yip, especialista como aposta no sportingbet cuidados animais do SeaWorld.

As duas baleias estão recebendo cuidados especializados para trauma de um time de "especialistas como aposta no sportingbet medicina, nutrição e comportamento" e dois cuidadores ucranianos estão ficando com elas pelos primeiros dois semanas para ajudar com a transição e o cuidado.
