## **CONTAINER ACTIVITY**

Various bits and pieces of seldom-used equipment has been placed at the back of the unit and the two tractors have been moved into it, too. Just about all the stone in front of the Headquarters Building has been dumped in front of containers 2 and 3 to provide something of a driveway and to get the stone out of the way so that work can continue on installation of the new siding. There is probably more to be done on container 2 so that the new car racks can be installed.

## PROJECT LIST


Additions and status:

1. Implement use of the third container - started
2. (new) Install new 1 ½” – 1” crossover
3. Complete the fence around the track
4. Upgrade the current signaling system - initial plan drafted
5. (new) Find drainage piping and fix
6. Install the third track (siding) at the Headquarters building (see December 2004 *Steam Whistle*)
7. Install new switches for the siding
8. Add siding signals to the signaling system
9. Upgrade the drainage systems
10. Install light pole at east side of steaming bays
11. Continue upgrade of track
12. Fix post holes for customer-control ropes at station
13. Install car racks in container #2

Work sessions are scheduled for Wednesday and Saturday mornings – say 9 o’clock or so. There is always something to do – see above. Thanks to those who have been giving their time.

## DIRECTIONS TO SNYDER'S

Snyder's Willow Grove Restaurant is on Hammonds Ferry Road, right off the Beltway (I-695) at Exit 8, south of Baltimore, between I-95 and the Baltimore-Washington Parkway. From the outer loop you can see Snyder's sign from the beltway; take exit 8 and turn right onto Hammonds Ferry Road at the end of the off-ramp. Snyder's parking lot is immediately on the right. From the inner loop, it is a little trickier; take Exit 8 which leads you to Fairview Avenue, then right onto Nursery Road. Travel under the beltway and turn right onto Hammonds Ferry at the first signal. Snyder's is about ¼ mile ahead, past the traffic signal and on the right.
