## ACTIVITY NOTES

In spite of some rather hot and humid weather, there has been some activity going on this month.

The grass is growing well and consequently needing constant cutting. The costs for gasoline are eye-opening. Several of the trees have awakened to the fact that it is a new season and have drooped branches into face level and sprouted a number of suckers. A number of hours have been expended trimming those trees – an annual effort. Those darn weeds have been attacked again with a hand-carried spray tank – or at least a tank carried on a modified golf bag carrier.

The tie stock has been cut and much of it turned into track panels. There are almost enough panels to re-lay all the track that has been pulled up so far, but more needs to be built up sometime when we get another supply of ties. A few sections of track have actually been installed. The current goal is to complete the length from the crossover above Hamilton Station across the driveway and a bit farther beyond. Then it will be necessary to determine if the installation continues around the outside loop towards the station or if anything is done pointing back towards Hamilton Station. At the south end of the crossover there is a mismatch between the existing track and the new. This leaves a break in the track making it useless even as a stub.

Finally, that routine mechanical maintenance has been performed when and where required.
